Rules

In addition to general and health rules:

- 1. Pre-registration of all birds is required by July 15. This will allow for better cage spacing and will keep all birds of the same breed together.
- 2. All chain birds must be in place by Friday 9:00pm and must be picked up by Saturday at 12:00pm.
- 3. All exhibits (other than chain birds) must be in place by Monday at 9:00pm and remain in place until released on the Sunday following the end of the fair and must be picked up by 12:00pm. See release schedule on general rules.
- 4. Each individual will be allowed 2 hens, 2 cocks, 2 cockerels and 2 pullets of each variety.
- 5. All birds, chain or other must be blood tested within 90 days of fair. Papers MUST enter barn before poultry enters.
- 6. All chain birds must be kept and cared for at exhibitors' residence and there will be no splitting of batches.
- 7. APA & ABA rules are applied based on Standard of Perfection.
- 8. No birds can be re-arranged in any manner after entry into the Poultry Building.
- 9. All poultry classes can be canceled at any time without notice by the Arkansas Livestock and Poultry Commission for bio-security reasons.
- 10. The Washington County Fair does not handle the sale of any birds. You must contact exhibitors directly if you wish to purchase any birds.
- 11. Final decisions, relative to Poultry Department will be made by the Poultry Superintendents.

Each member agreed to feed and care for the pullets under the Cooperative Extension Service and/or FFA Advisors guidance and to return 3 out of 15 Hyline Brown or 3 out of 20 White Leghorns for exhibiting at the Washington County Fair. All Pullets will go home with the exhibitor, and it is the exhibitor's responsibility to sell the pullets if so desired. All Pullets will be vaccinated throughout the growing period and will just be coming into production.

- I. All chain birds must be kept and cared for at the exhibitor's residence and there will be no sharing of batches.
- 2. All chain birds must be blood tested for exhibition at the Fair.
- 3. The participants are to return top quality pullets no culls accepted, and they must be in place at the fairgrounds by 9:00 pm, Friday.

Showmanship

Ages for showmanship are as of January Ist of the current year. Only exhibitors that exhibit in the junior department during the fair are eligible to show in the showmanship classes except Pee Wee. Market and Breeding exhibitors will show together in one combined showmanship show.

Must sign up online via ShoWorks along with your poultry entries or at poultry superintendent desk by Monday night. Showmanship will be at 6pm Wednesday.
