## Rules:

In Addition to General and Health Rules:

1. All Swine **must** have a 840 premise tag from the farm they were born. 4-H or FFA premise tags can no longer be used. **No Exceptions!** Once entered or Registered, hogs cannot be changed from **Registered, Market or Commercial**. They must show how they were first entered.
2. Shavings only will be used for bedding.
3. No water in pens.
4. Final breed classification will be determined during weigh-in by a committee chosen by the Superintendent. All decisions by the committee will be final.
5. Final decisions, relative to Swine Department will be made by the Swine Superintendents.

## Market Swine Rules

1. All market hogs must be tagged with 840 premise ID tag prior to the fair.
2. Exhibitor name (first and last name) and breed of animal must be declared when entered.
3. Maximum weight will be 290 lbs.
4. No Re-weighs will be allowed. No Exceptions!
5. Minimum of 5 (with minimum of at least 3 different exhibitors) for breed to be recognized. If less than 5 will show as AOB.

## Commercial Gilt Rules

1. Defined as any crossbred or any purebred gilt that is ineligible for registration
2. Gilt that are shown as Commercial Gilt are **NOT** eligible to show in the Market Hog Show
3. Commercial Gilt will show by weight with a Maximum weight of **325lbs.**
4. Commercial Gilt will have a separate champion drive where Champion & Reserve will be selected for Sale Order, followed by Alternates

## Washington County Born & Raised

Market Hogs must be born and raised in Washington County, have a premise ID tag from a Washington County herd, and a verification letter signed by the breeder. The verification letter must be turned in **by August 1<sup>st</sup> at presented at check-in.** The verification **letter to be used can be found on the fair website under the Fair book tab.** The show will be held concurrently with the Market Hog show. If necessary, a separate drive to determine Grand and Reserve Washington County Born & Raised will be held immediately following the Market Hog Grand Drive.

## Showmanship

Ages for showmanship are as of January 1<sup>st</sup> of the current year. Only exhibitors that exhibit in the junior department during the fair are eligible to show in the showmanship classes except Pee Wee. Market and Breeding exhibitors will show together in one combined showmanship show.

**Piglet** - Anyone 4 years old and under, who would like to enter this contest may do so. They do not have to be entered in any other class in the fair. They do not have to own the animal. It may be borrowed from one entered in the show. All participants will receive a Washington County Fair T-shirt.

**Pee-Wee** - Those youth who are less than 5-9 years old as of January 1<sup>st</sup> of the current year, may compete in this division. They do not need to be an exhibitor in the fair to participate. They may borrow an animal from an exhibitor. All Pee Wee participants will receive a T-Shirt from the Washington County Fair Association.

**Juniors** - Those Junior exhibitors 9-13 years old as of January 1<sup>st</sup> of the current year, who have not previously won the Junior Showmanship Contest at the Washington County Fair. Juniors who have previously won shall show in the Senior Showmanship.

**Senior** - Those Junior exhibitors 14-18 years old as of January 1<sup>st</sup> of the current year, (and JUNIORS who have won previous junior contests) who have not previously won the Senior Showmanship Contest are eligible.

**Advanced** - Only those Junior exhibitors of the WCF who have won a Senior Showmanship are eligible.
